AAP carries an extensive product line for cars, vans, sport utility vehicles and light trucks that serve both "do-it-yourself" (DIY) customers and commercial customers such as independent garages, service stations, and auto dealers through retail stores and the company website. Stores carry over 18,000 items, and have access to an additional assortment of 108,000 items offered for sameday or next-day delivery from either one of the company's 254 HUB stores or network of 22 Parts Delivered Quickly facilities. Additionally, customers have access to over 340,000 items by ordering directly from a store for delivery. The primary categories of product offered in stores include: parts (alternators, batteries, belts and hoses, chassis parts, clutches, engines and engine parts, ignition, lighting, radiators, starters, spark plugs and wires, transmissions and water pumps); accessories (floor mats, mirrors, vent shades, MP3 and cell phone accessories, and seat and steering wheel covers); chemicals,(antifreeze, brake and power steering fluid, and freon); oil, transmission fluid and other automotive petroleum products; and other miscellaneous products. Since 2000, Advance Auto Parts has aggressively expanded commercial sales through a commercial delivery program that utilizes delivery fleet to deliver product from store locations to businesses.



ADVANCE AUTO PARTS CEO TALKS SHIFTING VISION FOR NORTH HILLS HQ

That's according to CEO Tom Greco, who toured his new digs Thursday. Greco says the company is moving ahead full throttle with the new headquarters, despite the fact that the vast majority of the Raleigh operation is currently working from home.

The tower, which looms over Interstate 440, could start housing employees near the first of the year – that is if the pandemic situation allows its occupancy. Greco said his team is already planning how it can move forward in the new

space safely.

"We're going to move back into the office in a way that's safe for our people, and that may mean not everybody is there five days a week," he said. "We're looking at which roles can be effectively done remotely."

And there are challenges. The headquarters was designed to foster person-to-person relationships. Its open environment was specifically conceptualized for collaboration. So the question is, how to create the environment he's envisioning in the "new normal" of Covid-19?

Greco said he still doesn't have all the answers. His team is working on its floor plan to ensure desks are adequately spaced apart and having conversations with the builder about enhanced airflow systems.







Lake Ariel is a village in Lake Township, Wayne Count, Pennsylvania. Wayne County sits in the northeast corner of Pennsylvania, covering 763 square miles, and possessing all the natural beauty associated with the Pocono Mountains. The

Scranton, Pennsylvania is known as "the Electric City," and in recent years, it has become a poster child for legacy cities and efforts of revitalization.

This is a city that reclaimed its history as an industrial center while honoring its diverse heritage in a few key ways.

Scranton has recently become home to a vibrant arts scene and a walkable downtown that boasts farmers' markets, industrial buildings turned trendy lofts, special events and festivals.

had been a small farm community, has roots as a powerhouse of industry, producing coal, iron, steel, locomotives and records.

The steel and locomotive industries demanded coal, and to feed that demand, coal miners began mining the Northern Anthracite Coal Field, and outside demand for coal led to more railroad lines in turn. The demand for labor across industry resulted in a cultural melting pot – early Irish and Welsh immigrants were followed by Italian and Eastern European, all of whom brought their own cultural, culinary and religious traditions.


