







Monro Acquires QC Auto Service And Muscatine Tire & Auto Center

FEBRUARY 20, 2023 (MONRO)

Monro has acquired QC Auto Service and Muscatine Tire & Auto Center stores in the Quad Cities region of Iowa and Illinois. The five-store deal closed on February 19, 2023.

"We are thrilled to add QC Auto Service and Muscatine Tire & Auto Center to the Car-X brand," said Mike Broderick, Monro President and CEO. "They have provided great service to their communities for more than 40 years, and we will continue that commitment. We welcome their associates to the Monro team and look forward to serving their guests. The acquisition strengthens our current Car-X Tire & Auto presence in the Quad Cities and the surrounding area."

Five-store acquisition expands Monro's Car-X brand presence in the Midwest

The deal includes two QC Auto Service stores in Bettendorf, Iowa, and one each in Davenport, Iowa, and Moline, Illinois, as well as Muscatine Tire & Auto Center in Muscatine, Iowa. The **five stores** will be dual branded, adding Car-X Tire & Auto to their current identity. Approximately **30 associates** will join Monro through the acquisition, maintaining the stores' strong community relationships.

"It wasn't an easy decision for our family to sell our business, but it was the right time," said Dan Elias, owner and manager. "We knew that we could trust Monro to continue serving our **valued customers** and our employees."

The purchase increases Monro's service locations to **1,303 company-owned stores** across the United States, affirming the company's position as the second largest tire and automotive service company in the United States.

Monro, Inc. (NASDAQ: MNRO) is one of the United States' leading automotive service and tire providers, delivering **best-in-class** auto care to communities across the country. With a growing market share and a focus on sustainable growth, the company generated approximately **\$1.4 billion** in sales in **fiscal 2022**.



Monro Muffler Brake not stopping at 1,000 stores

The first Monro Muffler stood on Rochester's northeast side. It was there in 1957 that businessman Charles August opened a Midas Muffler franchise. Nine years later, August — now deceased — broke from Midas and started a new company that offered a wide array of car repair work.

The **1,000th Monro Muffler** is in Florida, one of **35 Tire Choice stores** Monro bought there this month in its first toehold into the Sunshine State. And in between, the **Rochester-based car-care** chain is becoming an **increasingly** common presence beneath the hoods of cars and light trucks across the eastern half of the United States.

Monro Muffler Brake Inc. now operates more than 1,000 stores across the eastern United States. And the chain has aggressive plans for yet more stores, as well as new markets, in coming years.

Under such brands as Monro Muffler, Mr. Tire, Tire Warehouse, Autotire, Tread Quarters, and Ken Towery Tire & Auto Care, it now operates 1,005 stores in 24 states. It moved into Kentucky in 2012 with the purchase of one existing chain, and into Michigan this June when it bought 19 tire and auto service stores there.

The move into Florida "helped balance us — we have a **lot of stores** in the mid-Atlantic, the Northeast," he said. "I never say never about anything. But within the next five years, I wouldn't plan on us being west of the Mississippi. I'd plan on us having a **lot more stores** east of the Mississippi. More in Florida. Probably add Georgia. A lot more within the states we currently operate in. We have **four stores** in Illinois. We're not at all in the Chicago area. We have a presence in Indiana, but it's **30-some stores**. Huge opportunities. Compare that to **150 in a state** like New York (where) we're not even in the real downstate markets. We've got such a huge amount of opportunity in our existing states, 'I don't need to think, 'Let's be in California.'





CEOs anticipate \$100M of new development in Oshkosh for 2024

Business is booming in Oshkosh. And they're anticipating at least another \$100 million of new development for 2024 despite inflationary pressures, rising interest rates, worker shortages and supply chain issues.

These were the findings of the Oshkosh Chamber of Commerce, which **polled 50 Oshkosh business executives** for their **annual economic outlook** survey. According to the poll, 76% of the participating CEOs rated their company's outlook as good to excellent over the next six months while that **figure grew to 89%** for the next 12 months, and **93%** over the next **one to three years**.

The consensus among local CEOs and business owners is that Oshkosh had exceptional financial growth last year after the city experienced more than \$57.3 million of investment in commercial and industrial property.

The survey went on to **show 58% of the local CEOs** and business owners polled reported an increase of sales last year **over 2022; 65%** indicated profits were up; and **59% revealed** their companies either met or exceeded profitability expectations.

"The results of this survey are very positive, and it shows Oshkosh is in a very good position in the marketplace, so that's good news for our local companies and good news for our market for growth and development," said Oshkosh Chamber President/CEO Rob Kleman.

"The results aren't surprising, either, because we're in a good market if you consider us as a part of the Fox River Valley, where there are **over 100,000 people** in that metro area.

"And our economy is very diverse from a sales, manufacturing and labor perspective, so while it's **50 businesspeople** we polled and not hundreds, this still gives us a good representation and we feel good in the **consistency** of the survey's results," he added.



Froedtert ThedaCare Health Breaks Ground On Hospital In Oshkosh, Wisconsin

The combined health system of Froedtert ThedaCare Health (Milwaukee) broke ground on a new hospital in Oshkosh, Wis.

Plans for the project include emergency care services, inpatient beds, a retail pharmacy, ambulatory surgery center with operating rooms, and a medical office building (MOB) housing primary care and specialty services.

The facility will feature 18-beds, a surgery center, and medical offices along the Fox River at Oregon Street.

The hospital is expected to be **completed by 2025**.


The project team includes HGA (architect and engineer; Milwaukee), Miron Construction (construction manager; Milwaukee), **The Sigma Group** (civil engineer and landscape architect; Milwaukee), and **Hplex Solutions** (owner representative; Appleton, Wis.).

In addition to the hospital in Oshkosh, Froedtert ThedaCare Health recently celebrated the **groundbreaking** of a health campus in Fond du Lac, which is slated to be completed in **2025**.
